



## HOLIDAYS LAST QUARTER 2025...

The last quarter of the year has arrived, which means that several international holidays are coming up in the next few months. These holidays may result in driving restrictions and/or temporary business closures.

Of course, we make every effort to adjust our services and planning as efficiently as possible to accommodate these circumstances. However, we would like to point out that changes to our services and delivery times cannot be completely avoided. We kindly ask you to take this into account, especially during the period around the dates listed below.



### REFORMATION DAY 31 OCTOBER..

In some countries, Reformation Day is an official holiday, with driving restrictions in effect. This affects our road transport to Belgium, France, and Germany. Please be aware of possible delays.



### ALL SAINTS' DAY 1 NOVEMBER..

All Saints' Day falls on a Saturday this year and does not impact our services.



### CHRISTMAS AND NEW YEAR..

During week 52 and week 1, our international services will be temporarily unavailable. Our services within the Benelux will remain limited during this period.

Additionally, our office will operate according to the following hours:

- 22 and 23 December: 08:00 – 17:00
- 24 December: 08:00 – 12:00
- 25 and 26 December & 1 January: Closed
- Week 1: 08:00 – 12:00

The following times apply for deliveries to our warehouse:

- 22, 23, 29 and 30 December: 07:00 – 15:00
- 24 and 31 December & 2 January: 07:00 – 12:00

To ensure that your goods arrive at their destination before Christmas, your shipments must reach Jan Krediet by the following dates at the latest.

#### NOTES ON COUNTRY CLASSIFICATION:

Region	Countries
Northern Europe	Scandinavian countries
Central Europe	Germany, Poland, Austria, Switzerland, Czech Republic, Hungary, Slovakia, Croatia, and France up to the Bordeaux and Lyon borders
Southern Europe	France from the Bordeaux and Lyon borders, Spain, Portugal, Italy, and Greece
Eastern Europe	Baltic states, Romania, and Bulgaria

### EPIPHANY 6 JANUARY 2026..

Epiphany is an official holiday in countries including Germany, Switzerland, Austria, Poland, Spain, Italy, Finland, and Sweden. This holiday affects our services and may cause delays. In week 2, road transport in Germany will only take place in zones 1 and 2. In Germany zones 3 and 4, as well as in Austria and Switzerland, no road transport will take place during week 2.
